Care Management for At-Risk Children

Qualifications:

Social Worker with a bachelor or master degree from an accredited social work program. Experience in case management and working with pregnant women, children and families is highly preferred.

Requirements:

Care Management for High-Risk Pregnancies (CMHRP)

- Care Management for High-Risk Pregnancies Program (CMHRP) is a service provided to Medicaid eligible pregnant women who are at risk for adverse birth outcomes.
- Assesses, plans, facilitates, care coordinates, evaluates and provides patient support to address health care and preventative service needs of pregnant and postpartum women. Provides Care Coordination focused on coordination of the patients' medical, nutritional, educational, social and emotional needs with private and community resources to promote healthy birth outcomes.
- Conducts community, physician practices, and patient home visits that are required for meeting program measures.
- Functions as a part of a multidisciplinary Care Management Team providing support and leadership on occasion to more medically complex patients and must be familiar with and aim to achieve the programmatic goals set forth by the prepaid health plans and State Medicaid.
- Performs additional duties as required by the Nursing Supervisor and Health Director.
- As a part of routine duties, this position will also be responsible and required to utilize multiple electronic medical records and State electronic documentation systems.

Care Management for At-Risk Children (CMARC)

- Care Management for At-Risk Children (CMARC) is a service provided to Medicaid eligible children ages 0-5.
- Coordinates services between health care providers, community programs and supports, and family support programs for children.
- The program promotes use of the medical home, links children and families to community resources and provides education and family support.
- Involves the parent/ caregiver (legal guardian when appropriate) in the decision-making process through a patient-centered, collaborative partnership approach to assist with improved self-care.
- Fosters self-management skill building when working with families of children.

- Prioritizes face-to-face family interactions (home visit, PCP office visit, hospital visit, community visit, video conferencing, etc.) over telephone interactions for children in active case status, when possible.
